#### The United Nations Holds The 54th Commission on the Status of Women

From March1 to March 12, the annual Commission on the Status of Women will hold its sessions at UN Headquarters in New York. The meetings this year have

special meaning to advocates for women's rights and gender equality because they mark 15 years since the



Fourth World Conference in Beijing(1995). The 12 critical areas of concern identified in the official outcome document of that Conference, most commonly referred to as the Platform for Action, remain today the global policy framework for women, guiding their work at global, regional and local levels.

Thousands of NGOs from around the world will gather to discuss and provide examples from their experiences to this year's theme—the contribution of the Beijing

Platform for Action to shaping a gender perspective toward the full realization of the Millennium Development Goals (MDGs).

The MDGs are widely embraced by UN Member States, UN agencies, international assistance organizations and NGOs as the development priorities for addressing the world's most pressing problems. Each of the eight MDGs has targets and indicators to measure the achievement of its goal and it is hoped that all of the MDGs will be achieved in every country by 2015.

Although it is widely acknowledged that empowering women is essential to achieving each of the MDGs, there is much concern that the targets and indicators for some of the MDGs are not adequate measures for the achievement of the goals. This year's Commission on the Status of Women will address how the more

comprehensive framework of the Platform for Action and the CEDAW Convention can be employed to expand the gender perspective toward achievement of the MDGs.

Zonta International will be represented at the CSW by President-elect Dianne Curtis, ZI UN Committee Chairman Jackie Shapiro and members of the ZI UN Committee Simone Ovart, Elisabeth Shuman, Karen Siegel and Mary Ann Tarantula. ZI Legislative Awareness and Advocacy Chairman Denise Conroy, Council of Europe Chairman Karen Nordmeyer and African Beijing+15 regional organizer Dunstanette Macauley will also represent Zonta.

The CSW will be preceded by a two-day NGO Forum. There will also be a luncheon honoring President-elect Dianne Curtis on March 6th at the Beekman Hotel in New York City.
